Faith and Practice of Baltimore Yearly Meeting, the Second Query: Meetings for Business

Are meetings for business held in a spirit of worship, understanding, and forbearance? When direction seems lacking, is this seen as a challenge to a more prayerful search for truth? Do we humbly set aside our own preconceived notions as to proper action, seeking instead Divine guidance as to the right course? Is the Meeting aware that it speaks not only through its actions but also through its failure to act? Do you participate regularly in meetings for business, discharge faithfully your committee responsibilities, and assume your share of financial support of the Meeting?

Faith and Practice of Baltimore Yearly Meeting, Advices for the Second Query:

Meetings for Business

As we approach our business we need to put aside how the world reaches decisions in temporal affairs and to recollect that we have come together to seek not equity, nor compromise, nor even the most "democratic" solution to the matter at hand but the Truth as God gives us to see the Truth. We believe that God is revealed and gives guidance to all who seek. Thus, in business meeting, we should listen to the views of all, just as we do in meeting for worship. We further believe that as Truth emerges we will have substantial unity in recognizing it, for Truth is undivided and that of God within each person responds to its presence.

We need to allow sufficient time for the conduct of the affairs of our Society. In our modern hurried life it may be hard to take time to search thoroughly for a right course of action. Failing unity, we may defer action until we can all see the Light together. Yet the practical business concerns we address in monthly meeting are as important to our individual and corporate life as the more directly spiritual concerns addressed in our meetings for worship.

Major items of business to be submitted to the Meeting should be prepared as carefully as possible by a Meeting committee or by preparatory work on the part of the Clerk so that pertinent facts and records of previous Meeting actions will be available to facilitate the discussion. Members not involved in the preparatory work should trust and value the work of preparation. Care should be taken to avoid reworking in a way that belittles the work already done.

When a matter requiring decision is placed before the Meeting by the Clerk or any other member, all who feel concerned to express their views should be heard. The Clerk should make sure that all points 1 of view are clearly stated so that the Meeting may have all it needs to arrive at a right decision. Words

and spirit should be those of loving helpfulness in search for the right way, the Truth, the best solution to a problem, rather than a position dogmatically asserted and adamantly held. All the time needed for deliberate consideration, including silences for prayerful reflection as needed, should be allowed. When it appears that there is general unity in the Meeting, the Clerk states what appears to be the sense of the Meeting. If the members approve, a minute expressing the sense of the Meeting is immediately written and is read and approved before the close of the session. In matters which are particularly important or complex it is best for the Meeting to compose, and request approval of, a minute before passing to other business. ...

Members should exercise forbearance in discussion and should seek Divine guidance, realizing that Truth will often transcend the understanding of any single individual. When the judgment of the Meeting appears to be tending away from the opinion of a member, that Friend should consider whether to stand aside or to prevent the consensus required for the Meeting's action. When the Meeting cannot unite upon a minute, no action is taken on the matter, which may be postponed for further consideration. Any previous action or policy of the Meeting in the same area stands in the absence of a specific Meeting decision to change it. Friends are reminded that failure to act is also a form of judgment and are urged to consider seriously the nature of their guidance to stand opposed to a view which has clearly received the assent of most Friends in the Meeting. At the same time Friends are mindful of the many occasions when the leading of one or a few has proven to be the way of Truth. When action appears to be blocked by one or a few Friends, the Meeting may find it useful to appoint a special committee to labor with all concerned for a resolution of the impasse.

<u>WEBINAR ON NUCLEAR BAN TREATY</u>: Saturday, February 27, 10:00 a.m. – noon. Zoom information will be forthcoming.

From Jean Athey (Peace and Social Justice Committee): As you may recall, at the last Business Meeting, the Meeting agreed to place a banner on the grounds for one month, beginning on Sat., Jan. 23, informing the community of the important new UN treaty to ban nuclear weapons, which goes into effect on Friday, Jan. 22. At the January business meeting, two suggestions were made to me: (1) To disseminate a flier about the treaty and the role of JHU in research on nuclear weapons, and (2) To organize a Webinar through BYM about the treaty. I've attached a flier that you can use as you see fit and now I want to give you information about what I believe will be an excellent Webinar. *Please plan to participate!*

The BYM Peace and Social Concerns Committee has agreed to be the sponsor of a Webinar on the nuclear ban treaty, and other groups are either considering or have decided to be cosponsors (e.g., MD Peace Action and Chesapeake Physicians for Social Responsibility will cosponsor and the MD Poor People's Campaign is considering doing so). The Webinar will be a conversation with Joseph Gerson, followed by Q&A. Dr. Gerson is president of the Campaign for Peace Disarmament and Common Security, Vice-President of the International Peace Bureau, Co-founder of the Committee for a SANE U.S.-China Policy and of the Asia Pacific Working Group, among other important roles. Before his retirement, he worked for AFSC for 44 years, where he directed the Peace and Economic Security Program. He has published widely, including important books on nuclear weapons. We are indeed fortunate to have secured such a terrific speaker for this Webinar, someone with the Quaker experience that he has!

Please put the webinar on your calendar now and encourage your friends to do so. Thank you so much for your support for ridding the world of these terrible weapons—before they destroy life on the planet as we know it.

VIRTUAL TOUR OF THE LILLIE CARROLL JACKSON CIVIL RIGHTS MUSEUM:

Saturday, February 27, 1:00 - 2:00 p.m. Last year a number of us had the good fortune to take a physical tour of the Lillie Carroll Jackson Civil Rights Museum on Eutaw Place in Baltimore City. Lillie Carroll Jackson (1889 – 1975) was a pioneer civil rights activist and organizer of the Baltimore branch of the NAACP. Invariably known as "Dr. Lillie", "Ma Jackson", and the "mother of the civil rights movement", she pioneered the tactic of non-violent resistance to racial segregation used by Martin Luther King Jr. and others during the early civil rights movement. In her will, which established her Eutaw Place home as a museum, Lillie Carroll Jackson indicated that a room should be devoted to Margaret Thomas Carey, a Homewood Quaker. We will learn about Margaret T. Carey and her collaboration with Lillie Jackson. Your Homewood Centenary Working Group (planning the Homewood centennial celebration) is planning on lifting up the friendship and collaboration between these two women in a new installation in the Homewood lobby.

WORKING FOR CHANGE: RACIAL EQUITY AT HOMEWOOD

<u>How to be an Anti-Racist</u>. On Saturday, January 9th, Homewood held a virtual presentation/workshop called "How to be an Anti-Racist" by Clinton Pettus. It was well attended by over 30 members and attenders. Through a survey administered after the presentation, participants offered the following insights.

To the question, "On a personal and spiritual level, what 1-3 topics from the presentation do you personally want to explore, and how can we best support you?" friends offered the following thoughts:

- Unlearning automatic responses, bringing the unconscious to consciousness
- Micro aggressions and implicit bias;
- Misconceptions Quakers have about slavery and inclusion of people of color (POC) in the Society of Friends;
- How to welcome and keep POC in our meeting
- Reparations

To the question, "If Homewood is to become an anti-racist organization, what do you think we should explore or act on in the next year," friends offered these thoughts:

- I think we need to care about Black Baltimoreans' actual experiences and how being Black in the US affects them...Recommend Basics reading... then move as many HFM folk to participate in some interdenominational and multiracial activities Bible study, interfaith BLM group's online rallies, visit black services online ... and circle back to share learnings.
- Engage as many folks as possible. Determine if this is what we want to do as a meeting. Focus
 on looking at ourselves and white privilege and micro-aggressions before we reach out to Black
 churches.
- Assess policies and practices for exclusionary messages/impact, using BYM queries.

Aiming for Justice: Race Reparations and Right Paths: Feb 1-26, 2021, with K. Melchor Quick Hall via Zoom. 3 times a week - Monday, Wednesday, and Friday - for 4 weeks. Spring Lobby Weekend, March 20-22 Online.

Our country needs urgent action to end the crisis of systemic racism and militarization in policing. We have the opportunity to influence legislation in the first 100 days of the new Biden administration and see meaningful change.
