The Protecting Sensitive Locations Act (HB1006) directs the Attorney General to issue guidance limiting immigration enforcement access to schools, healthcare facilities, places of worship, social services providers, and other essential spaces, and for state agencies to develop policies that enforce that guidance. The bill was introduced by Delegate Jheanelle K. Wilkins and Delegate Jared Solomon in the Maryland

This bill will create guidance to protect sensitive locations in Maryland.
